Whereas, pursuant to recommendations of Service Selection Board J&K as communicated vide letter No's. SSB/Secy/Sel/J/K/div/2022/5889-94 dated:-02.09.2022 and JKSSB-SD0SECY(KAS)39/2022-03 dated:- 19 .09.2022, and subsequent to the recommendations of Finance Department to this Directorate vide No's:- FD-FO/31/2022-03 dated:-08.09.2022 and FD-FO/31/2022-03 dated:-21.09.2022, **19 (nineteen)** candidates were temporarily appointed as Assistant Compilers in J&K Funds Organization Finance Department Divisional Cadre Kashmir vide Order No 177 DGF of 2022 dated: 11.11.2022;

Whereas, the appointed candidates were posted in different Fund Units of J&K Funds Organization;

Whereas, out of 19 candidates only 18 candidates joined at their respective place(s) of posting(s);

Whereas, Joint Director, J&K Funds Organization Kashmir communicated that one appointee namely Ruksana Nazir D/o Nazir Ahmad Mir, R/o Nowpora Dangwacha, District Baramulla falling under RBA Category, did not join at her respective place of posting within stipulated period of 21 days from the date of issuance of the appointment order;

Whereas, in terms of Circular No. 08-JK(GAD) of 2019 dated 04-12-2019 issued by General Administration Department J&K, the candidates who fail to join within a period of **21 days** from the date of issuance of the appointment order shall forego his/her right to appointment which shall be deemed to have been cancelled *ab-initio* without any further notice;

Whereas, cancellation of appointment order of Miss Ruksana Nazir D/o Nazir Ahmad Mir, R/o Nowpora Dangwacha, District Baramulla falling under RBA Category as Assistant Compiler was issued vide this Directorate's order No. 32-DGF of 2023 dated: 08.03.2023;

Whereas, afterwards this Directorate vide letter no. DGF-PS/48/197299/205 dated: 27.03.2023 sought approval for operationalisation of waiting list from the Administrative Department against the non-joining candidate under RBA category;

Whereas, Administrative Department vide their letter no. FD-FO/31/2022-03 dated: 25.07.2023 conveyed Administrative Approval for operationalisation of waiting list against the candidate who failed to join in the department for appointment of the candidate from the waiting list in the relevant category;

Whereas, Shakir Nazir, S/o Nazir Ahmad Malla, R/o 10-Kartargrah, Alsafa Colony, Sopore, Tehsil Watergam, District Baramulla, is figuring on top in the waiting list under RBA category;

Whereas, the final verification report of Character and Antecedents in favour of said incumbent has been received by this Directorate from the CID, J&K vide form no: 69484 dated: 31.07.2023.

Now, therefore, as per the selection list furnished by J&K Service Selection Board and subsequent to the recommendations of Finance Department to this Directorate vide above mentioned references and further on the basis of Final verification of Character and Antecedents of the selected candidate as conveyed by the CID JK, Sanction is hereby accorded to the temporary appointment of Shakir Nazir, S/O Nazir Ahmad Malla, R/O 10-Kartargrah, Alsafa Colony, Sopore, Tehsil Watergam, District Baramulla, under RBA category as Assistant Compiler in Pay Level 4 (25500-81100) Divisional cadre Kashmir.

The appointee is hereby posted in the office of Chief Accounts Officer, District Fund Office Baramulla as Assistant Compiler. He shall report physically in the office of Chief Accounts Officer, District Fund Office Baramulla within a period of 21 days from the issuance of this order and in case the appointee fails to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice as per the circular No. 08-JK(GAD) of 2019 dated 04.12.2019.

## The appointment shall be subject to the following conditions:-

## A. The appointee shall be allowed to join only on production, checking and Verification of the following certificates in original:-

- 1. Academic Qualification Certificate.
- 2. Matriculation/ Date of Birth Certificate.
- 3. Health Certificate issued by Chief Medical Officer concerned.
- 4. Domicile Certificate issued by the Competent Authority..
- 5. Category certificate wherever applicable.
- 6. Any other relevant certificates as required under rules.
- **B.** The appointment of the candidate shall further be subject to the following conditions to be fulfilled by the Head of Office/DDO and also ascertaining genuineness of the certificates and recognition status of the institutions:-
- 1. The candidate shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his **academic/ technical/ category certificate,** is received, from concerned authority, he shall have no right to claim his appointment as Assistant Compiler and the same shall be deemed to have been cancelled ab-initio.

- 2. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
- 3. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio and this office be kept posted so that appropriate criminal proceedings against the candidate is initiated.
- 4. The salary of the appointee shall not be drawn and disbursed to him until and unless satisfactory report about genuineness of his certificate(s) is received from the concerned quarters.
- 5. The appointee shall be on probation for a period of two years.
- 6. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
- 7. The inter-se-seniority of the appointee shall be in the order of merit list issued vide No:- SSB/Secy/Sel/J/K/div/2022/5889-94 dated:- 02.09.2022 by the J&K Service Selection Board.
- 8. The appointment shall be subject to outcome of writ petition(s) if any pending disposal before any competent court of Jurisdiction related to the selection list.
