Subject: - Final Refund/Payment of GPF Balance of NPS Subscribers and implementation mechanism thereof.

Ref: - Government Order NO: 153-F of 2021 dated: - 05-05-2021.

The Finance Department vide Order No: 266-FD of 2020, dated: 28-09-2020, among other things, provided the method and manuer in which GP Fund accumulation is to be refunded to NPS Subscribers. Para third of the Order reads as under: -

" DDO's shall provide list of NPS Subscribers on their establishment on the prescribed format to the concerned fund offices for issuance of DDO wise authority".

Accordingly, for the smooth implementation of aforementioned Govt. Order, it is as such impressed upon all concerned DDO's and Fund Units that: -

 All the DDO's shall submit the list of NPS employees presently working on their establishment to concerned Fund Office as per below mentioned format at an earliest, well before 01.06.21, both in hard and soft form, under seal and signature of the DDO concerned.

In case of NPS subscribers, having balance with more than one Fund Office, the same shall be got transferred to the existing Fund Unit with which their DDO is currently mapped. The process for transfer of balance of such NPS subscribers will be initiated by their current DDOs. 3. On receiving the above list from DDO, the District Fund Office shall check the details with their records and prepare a SINGLE AUTHORITY in the name of DDO concerned, indicating the amount payable as 50% (first installment) of total accumulation of all the NPS subscribers on his establishment. The single authority shall be annexed with the list of all NPS subscribers pertaining to that DDO, in whose favour payment has been authorized in the below given format:

4. 50% residual Payment (second installment) will be made by the Fund Offices in the same manner as indicated at 3 above, in shape of a single final GP Fund authority, after adding the interest as per govt order no 154-F dated 05.05.2021. Thereafter, all the account of the NPS subscribers shall be closed by the Fund offices permanently. This authority shall be annexed with the list in the below given format:
