- 1. Whereas, Finance Department Vide No:-FD-Estb/56/2021-03 dated: 06.10.2021 forwarded selection list of 647 candidates along with waiting list for the post of Assistant Compiler Divisional Cadre Kashmir under Hon'ble Prime Minister's Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits received from the department of Disaster Management, Relief, Rehabilitation and Reconstruction, J&K vide O.M No:-DMRRR-MR/154/2021 dated:- 05.10.2021 for verification of Character and Antecedents of the candidates in line with Government order No. 528-JK (GAD) of 2021 dated: 21.06.2021 and1003-JK(GAD) of 2021 dated 27.09.2021;
- 2. Whereas, after receiving the verification reports from CID J&K, the appointment order in respect of 585 candidates was issued vide various orders from time to time by this Directorate;
- 3. Whereas, the Administrative Department vide letter No. FD-FO/16/2022-03 dated: 09.09.2022 has conveyed approval for operating of waiting list against the candidates who have failed to submit their Verification Rolls;
- 4. Whereas, 39 candidates figuring at the top in the waiting list in order of merit to their respective categories were intimated to submit their V-Rolls;
- 5. Whereas, only 33 candidates submitted their V-Rolls and the same were forwarded to CID, J&K for verification and subsequently this Directorate received verification of character and antecedents in favour of these 33 candidates;
- 6. Whereas, sanction for operating the waiting list, was received after expiry of validity period provided under rules and this Directorate again took up the matter with Administrative Department for extension of validity of waiting list;
- 7. Whereas, the Competent Authority has accorded its approval for extension of select list/waitlist issued by JKSSB vide No. SSB /Sel /Secy /M/ 03/ 2021 /6314-20 dated:- 23.09.2021 in relaxation of Rule 4 (5) and 14 (7) of Jammu and Kashmir Civil Services Decentralization and Recruitment Rules 2010 for a period of one month from the date of receipt of sanction/approval in the Finance Department for issuance of appointment orders as Asstt. Compilers in favour of 33 candidates and same has been communicated to this Directorate by the Administrative Department vide letter No. FD-FO/16/2021-03 dated: 04.09.2024.

Now in pursuance of the approval accorded for operating the said waiting list, sanction is hereby accorded to the temporary appointment of 33 (thirty three) candidates (out of waiting list), as listed in Annexure "A" to this order, as Assistant Compilers in Pay level 4 (25500-81100) Divisional cadre Kashmir under Hon'ble Prime Minister's Special Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits.

## The appointment shall be subject to the following conditions:-

- A. The appointees shall be allowed to join only on production/ checking/ Verification of the following certificates in original:-
- 1. Academic Qualification Certificate.
- 2. Matriculation /Date of Birth Certificate.
- 3. Health Certificate issued by Chief Medical Officer concerned.
- 4. Domicile Certificate issued by the Competent Authority.
- 5. Migrant Registration Certificate.
- 6. Valid relevant reserved category certificate wherever applicable.
- 7. Any other relevant documents, if required.

## B. The appointment of the candidates shall further be subject to the following conditions that:-

- 1. The candidate shall execute an agreement in the "form" prescribed under Jammu & Kashmir Migrant (Special Drive) Recruitment Rules, 2013, issued under SRO-412 of 2009 dated 30-12-2009.
- 2. If the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
- 3. They shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his/her Character & Antecedents/Academic/ Technical/ Category certificate, is received, from concerned authority, he/she shall have no right to claim his appointment as Assistant Compiler and the same shall be deemed to have been cancelled ab-initio.
- 4. If on verification, the certificate(s) produced by the appointee(s) are proved to be fake or forged, the appointment shall be cancelled ab-initio and appropriate criminal proceedings against the candidate shall be initiated.
- 5. The salary of the appointee(s) shall not be drawn and disbursed to him/her until and unless satisfactory report about genuineness of his/her Qualification/Date of Birth/relevant category certificate & any other certificate is received from the concerned quarters, besides afresh character and antecedents is obtained from the CID, J&K.
- 6. The appointee shall be on probation for a period of 02 years.
- 7. The appointees shall report to the Joint Director, J&K Funds Organization, Haft Chinar, Finance Complex, Kashmir, Srinagar within a period of 21 days from the date of issuance of appointment order. In case the appointee(s) fails to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice as per Circular no. 08-JK(GAD) of 2019 dated 04.12.2019.
- 8. The Joint Director, Funds Kashmir shall issue formal orders for their posting.

- 9. The appointment of the candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
- 10. The inter-se-seniority of the appointees shall be in the order of merit list issued vide No:- SSB/Sel/Secy/M/03/2021/6314-20 dated:- 23.09.2021 by the J&K Service Selection Board.
- 11. The appointment shall be subject to outcome of writ petition(s), if any, pending disposal before any competent court of Jurisdiction related to the selection.
